

What is the purpose of this insurance program?
This insurance is designed to cover third parties who don't already have insurance for their liability arising out of their activities while on church premises.

Who are third parties?

Third parties are **Groups or Individuals** that use Church premises for single or recurring events.

Examples of **Group Users** are:

- Youth Study Groups
- Alcoholics Anonymous
- Yoga/Cooking/Craft Classes
- Drama/Chess/Bridge Clubs
- Generally all regular meetings

Examples of **Individual Users** are:

- Weddings
 - Dances
 - Local Fund Raising events
 - One-time only meetings
- Can anyone enroll?*
No. Nurseries; Day Cares; Montessori Schools, and other Churches or congregations are not eligible.

What does this insurance program cover?

The policy covers you for your legal liability imposed by law for Bodily Injury and/or Property Damage to a third party that arises from your operations conducted on the Church premises. (Coverage is provided only while on Church premises and excludes abuse/molestation.)

Limits of Liability:

- \$2,000,000.00 Each Occurrence
- \$2,000,000.00 Annual Aggregate
- \$ 250,000.00 Tenants Legal Liability

Deductible:

- \$500.00 Bodily Injury and Property Damage including Legal Expense.
- \$500.00 Tenants Legal Liability
